Building Upon the Legacy of Impact

Key Highlights of 2023-2024

Enhancing Customer Service and Program Growth

NCQA Accreditation

In 2023, the AAA5 achieved Case management Long-Term Services and Supports (LTSS) accreditation by the National Committee for Quality Assurance (NCQA) for the following programs: PASSPORT and Assisted Living, Ohio Home Care Waiver, and Specialized Recovery Services.

With the workforce shortage of home health care providers, the Community Care Services Program was established in 2021, hiring STNAs. Supervised by a Registered Nurse, the specialists experience a hybrid work environment. They obtain in-office skills, mentorship, and leadership development, while providing their client's in-home personal care and homemaker services, when clients are unable to be served by our provider network. Seeing the success of this program, the AAA5 requested and was granted a waiver by Ohio Department of Aging, to offer direct in-home personal care and homemaker services – requesting a waiver to offer this from the Ohio Department of Aging, it allows us to broaden our services beyond

the scope of the Richland County Senior services levy, thereby extending care to areas outside Richland County.

In 2023, we were recognized as a recipient of the USAging Aging Innovations Award for innovation of this program.





Ohio Home Care Waiver and Specialized Recovery Services

We have expanded into Licking, Union, and Delaware counties where we administer the Ohio Home Care Waiver (OHCW) program, providing essential services to more seniors. Operated by the Ohio Department of Medicaid, this provides home- and community-based services for individuals with physical disabilities and unstable medical conditions, enabling them to receive care at home and remain active in their communities while making important choices about their care.

Benefits Enrollment Center (BEC)

Funded by the Administration for Community Living, the Agency continues to receive support through the National Council on Aging's Benefits Enrollment Grant, originally awarded in 2021. This funding enhances efforts to connect Medicare beneficiaries with limited incomes to essential benefits for health care, food, and more. By incorporating the initiative into social engagement activities, the Agency not only promoted the program and supported social connections but also created opportunities to share its broader range of services and programs.

Promoting Safety, Independence, and Well-Being

Wellness Programs

Increasing the footprint of the Healthy and Safety initiatives through educational programs to enhance wellness, manage chronic diseases, and prevent falls, we have successfully trained volunteer coaches and recruited more participants for the education programs such as Active Living Every Day, Diabetes Empowerment, Matter of Balance, Tai Chi, and Stepping On. By providing additional training for volunteer coaches, we aim to reduce the waiting list, improving both class availability and accessibility"

Adult Protective Services

Administering Adult Protective Services (APS) in Marion, Crawford, Knox, and Wyandot counties, we investigate abuse, neglect, and exploitation of older adults. With rising reports of exploitation and challenges like financial scams, opioid abuse, and mental health issues, we partnered with community organizations, health professionals, and law enforcement to provide outreach and education. In 2023, we received 991 APS referrals, with 217 for exploitation, and projections for 2024 indicate continued increases. Supported through the State Opioid & Stimulant Response grant, we had the opportunity to partner with local health systems to deliver opioid awareness training for in-home providers and facilities, enhancing support to address the growing number of older adults impacted by substance abuse.

Amazon Ring Community Program

We are proud to be one of ten AAAs nationwide partnering with USAging and Amazon Ring to enhance safety and independence for older adults, caregivers, and individuals with disabilities. Through the Community Ring Initiative, Amazon donated devices, with a lifetime subscription, leverages technology to support home safety. Following a phased rollout based on eligibility, we look forward to distributing these devices to those in need.

Service Coordination

Connecting residents with resources to support independence and well-being, the Agency has expanded this valuable service from 4 to 6 sites and now serves over 500 residents. In addition to Canton Towers (Canton), The Woods (Mansfield), Faith Community (Crestline), and Union Lofts (Ashland), this service now includes Stratford East (Canal Winchester), and Ritter's Run (Mansfield).

Richland County Senior Services Levy

The AAA5 administers the Richland County Senior Services Levy, originally approved by voters in 2008 as a 5-year, 1-mill levy to support programs and services that

help residents age 60 and older live safely and independently while enhancing their well-being. To support the growing need in Richland County, the levy continues to fund important services such as essential services such as homemaker assistance, personal care, emergency response systems, case management, information and referral, congregate and homedelivered meals, programs addressing social isolation, transportation, and wellness education. In May 2023, voters renewed the levy for a third time.

Richland County Mobility Management

To meet the increasing transportation needs of older adults and individuals with disabilities, the AAA5 now administers Mobility Management in Richland County. A collaborative transition from the Richland County Regional Planning Commission to AAA5, builds on a long-standing partnership, ensuring the program's growth and innovation while addressing transportation gaps.

Healthy Aging Grant

The Healthy Aging Grants, allocated by the Ohio Department of Aging to county commissioners across the state, provided vital support for older adults. We were honored to administer these grants for Morrow, Crawford, Knox, Wyandot, and Richland Counties, while also collaborating with commissioners and community-based organizations in Ashland, Marion, Seneca, and Huron Counties. These grants funded initiatives focused on housing, health, wellness, and independence for older adults. Projects included utility assistance, transportation, chore services, emergency response systems, Knox Boxes, nutrition support, technology education, and social connection events to combat isolation.

Ritter's Run

A major achievement in 2024 was the successful opening of Ritter's Run Senior Apartments in Mansfield, OH, marking a significant step forward in addressing the need for affordable housing for seniors. This initiative has already made an impact, with 12 individuals now calling Ritter's Run home. Beyond providing safe and affordable housing, the Agency is delivering ongoing service coordination to ensure residents have access to essential resources and support, fostering their well-being and independence. This project exemplifies the strength of public-private partnerships in driving meaningful and lasting change for older adults in our community.







Veterans Directed Program

This program allows veterans to remain at home by managing their own care budgets and choosing caregivers and services. AAA5 will administer this program in partnership with the VA, providing needs assessments, individualized care plans, and budget management support to help veterans maintain independence and quality of life.

Technology Strides

More Than a Meal


The Campus Dine Program, launched in 2017 in partnership with the Ohio State University – Mansfield, transitioned to digital transaction cards in 2023, offering nutritious, flexible meals while fostering intergenerational connections and reducing social isolation. With 18,669 meals served and an average of 300 participants, the program continues to make a meaningful impact. Similarly, the Hawkins Congregate Meal Site provides not only meals but also social engagement and enriching programs such as art, wellness, and technology, addressing food insecurity and strengthening community connections.

Programming Across Communities

AAA5 and its county focal points identified existing needs and service gaps as a result of the pandemic. Recognizing the importance of technology for vulnerable and isolated older adults, the initiative worked to improve equipment and technology platforms, enabling successful delivery, while sharing programming content and increasing social engagement across rural communities. We were honored by USAging, Caregiving.com, and Cumulus and recognized as an Aging Innovation & Achievement Awards recipient in July 2024.


